Sec. 3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

17 **FISCAL NOTE**

19 This bill will result in a decrease of dedicated revenue of  
21 \$25,500 in each fiscal year. Current allocations that are based  
23 on these dedicated revenues are deallocated. General Fund  
25 appropriations of \$115,754 in fiscal year 1989-90 and \$125,420 in  
27 fiscal year 1990-91 are included in this bill. The same level of  
funding has been included in the Governor's supplemental budget  
request. If this or some portion of this funding is approved by  
the Legislature, then the appropriation section on this bill  
should be adjusted accordingly.'
