STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-NINE

An Act to Improve and Enhance the Quality and Amount of Instructional Time for Students.

1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 20-A MRSA §4502, sub-§5, \P L, as amended by PL 1985, c. 774, §§4 and 11, is further amended to read:

L. Prepare and implement an en-geing ongoing school improvement process and annually update a written school improvement plan, including <u>a plan for improving and</u> <u>enhancing the quality and amount of instructional time for</u> <u>students</u>, a fully developed staff development plan and a plan addressing truants, dropouts, alternative education, prevention of truancy and return to school, citing progress and trends with respect to school improvement.

15 Sec. 2. 20-A MRSA §4801, sub-§1, as amended by PL 1985, c. 624, is further amended to read:

1. Number. A school administrative unit shall make 19 provision for the maintenance of all of its schools for at least 180 days a year, through the 1989-90 school year, with a minimum 21 increase of one additional day each year beginning with the 1990-91 school year, resulting in a minimum of 185 days in 1994-95 and thereafter. At least 175 days shall be used for 23 instruction through the 1989-90 school year resulting in a minimum of 180 instructional days in 1994-95 and thereafter. 25 In meeting the minimum school year requirement of-a-180-day-school 27 year,-no-more-than , as many as 5 days may be used for in-service education of teachers, administrative meetings, parent-teacher 29 conferences, records' days and similar activities.

- A. The commissioner may reduce or waive the minimum number of days required on application from a school board. The application must be supported in writing with a statement of the reasons for the request.
- в. Notwithstanding any other section of the statutes, 37 school committees, with the approval of the commissioner, may adopt or amend rules necessary to implement an extended 39 school year at the local level. The commissioner may make appropriate adjustments, not to exceed the allowable 41 subsidy, to insure fair and equitable treatment in the distribution of state aid.
- C. Notwithstanding this subsection, the commissioner shall promulgate a rule to provide that local school units may allow secondary school students to graduate up to 5 school days prior to the regular end of the school year.
