COMMITTEE AMENDMENT "A" to H.P. 968, L.D. 1346, Bill, "An Act to Authorize a General Fund Bond Issue in the Amount of \$3,000,000 to Protect Ground Water Quality and Public Health Through the Cleanup and Closure of Municipal and Abandoned Solid Waste Landfills"

Amend the bill in the title in the 2nd line by striking out the following: "\$3,000,000" and inserting in its place the following: '\$6,000,000'

Further amend the bill in section 1 in the 5th line (page 1, line 13 in L.D.) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$6,000,000'

Further amend the bill in section 6 in the last line (page 2, line 13 in L.D) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$6,000,000'

Further amend the bill in section 10 in the question in the first line (page 2, line 46 in L.D) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$6,000,000'

Further amend the bill by inserting at the end before the statement of fact the following:

**FISCAL NOTE**

The cost of this bond issue is estimated to be \$6,975,000 with principal payments of \$6,000,000 and interest payments of approximately \$975,000.

Also, the estimated cost of sending this question out to referendum will vary according to the total number of referenda enacted by this session of the Legislature. The estimated cost to the Secretary of State if one to 6 referenda are presented to the voters is \$88,000. Each additional referendum costs an additional \$5,300.'
