SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to S.P. 496, L.D. 1370, "Resolve, to Study the Feasibility of Establishing a Piscataqua River Basin Compact between Maine and New Hampshire"

Amend the amendment by inserting after the title the following:

'Amend the resolve by striking out all of the emergency preamble.

Further amend the resolve in the 6th "**Resolved**" paragraph from the end in the 4th line (page 2, line 13 in L.D.) by striking out the following: "August 1, 1989" and inserting in its place the following: 'May 1, 1990' '

Further amend the amendment in the first indented paragraph after the title in the first line (page 1, line 17 in amendment) by striking out the following: "Amend" and inserting in its place the following: 'Further amend'

Further amend the amendment in the 2nd indented paragraph after the title in the 2nd line (page 1, line 22 in amendment) by striking out the following: "December 1, 1989," and inserting in its place the following: 'November 1, 1990, and present it' and in the next to last line (page 1, line 24 in amendment) by striking out the following: "Resources" and inserting in its place the following: 'Resources by December 1, 1990'

Further amend the amendment in the appropriation in the 17th line (page 2, line 18 in amendment) by striking out the following: "commission." and inserting in its place the following: 'commission. These funds shall carry forward to June 30, 1991.'

Further amend the amendment by inserting after the 7th indented paragraph after the title the following:

'Further amend the resolve by striking out all of the
emergency clause.'

STATEMENT OF FACT

This amendment removes the emergency preamble and the
emergency clause from the resolve, and changes the date for
convening the Commission to Study the Feasibility of Establishing
a Piscataqua River Basin Compact between Maine and New Hampshire
until May 1, 1990 and the dates for completion of commission work
and reporting to November 1, 1990 and December 1, 1990,
respectively. The amendment also provides that funds will carry
forward to June 30, 1991.

The change in date will allow the New Hampshire legislature
to entertain a similar proposal during its next session.
