

IN THE YEAR OF OUR LORD
NINETEEN HUNDRED AND EIGHTY-NINE

An Act to Set Up Therapeutic Foster Homes.

(EMERGENCY)



1 **Emergency preamble.** Whereas, Acts of the Legislature do not
2 become effective until 90 days after adjournment unless enacted
3 as emergencies; and

4 Whereas, there are many children in need of supervision and
5 treatment outside the home for whom placements are currently
6 unavailable; and

7 Whereas, many of these children would benefit from placement
8 with a foster family if adequate training and support services
9 were made available to foster parents to establish these homes;
10 and

11 Whereas, in the judgment of the Legislature, these facts
12 create an emergency within the meaning of the Constitution of
13 Maine and require the following legislation as immediately
14 necessary for the preservation of the public peace, health and
15 safety; now, therefore,

16
17 **Be it enacted by the People of the State of Maine as follows:**

19 **Sec. 1. 34-B MRSA §6201, sub-§1-A is enacted to read:**

21 **1-A. Child in need of supervision.** "Child in need of
22 supervision" means a child up to 18 years of age who may benefit
23 from services and who is:

24 **A. Runaway or homeless;**

25 **B. Repeatedly aggressive toward family members or property;**

26 **C. Repeatedly disobedient to reasonable and proper orders**
27 **of a parent, guardian or other custodian or who is beyond**
28 **the control of a parent, guardian or other custodian;**

29 **D. Truant;**

30 **E. Not currently or consistently being served optimally by**
31 **the system or agency with whom the child is involved;**

32 **F. Not voluntarily accepting services; or**

33 **G. Is in a family at risk.**

- 21 (8) Professional consultation and training;
- 23 (9) Respite care and other family support services; and

27 **Sec. 4. 34-B MRSA §6204, sub-§1, ¶D** is enacted to read:

29 D. Ensure that services are available to address the
31 problems of children in need of supervision.

33 (1) The bureau shall provide or arrange for the
35 provision of at least the following services:

37 (a) Administrative services; and

39 (b) Services delivery systems, including:

41 (i) Evaluation and assessment services;

43 (ii) Respite care and other family support
services;

45 (iii) Homeless shelters and emergency
47 shelters; and

49 (iv) Therapeutic foster homes.
