Resolve, that the Deadline for the Revision of the State's Motor Vehicle Laws be Extended .

(EMERGENCY) (After Deadline)

1 Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and 3 5 Whereas, in 1987, a recodification of the Maine Revised Statutes, Title 29, was authorized by Resolve 1987, chapter 33; 7 and Whereas, technical difficulties were encountered g in preparing the materials for that recodification; and 11 Whereas, more time is required to properly complete the 13 recodification: and Whereas, in the judgment of the Legislature, these facts 15 create an emergency within the meaning of the Constitution of 17 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 19 safety; now, therefore, be it Resolve 1987, chapter 33, amended. Resolved: That Resolve 1987, 21 . chapter 33, the last 3 resolve clauses are repealed and the following enacted in their place: 23 Report to the Legislature. Resolved: That the Department of the 25 Secretary of State present its report and revision of the Maine Revised Statutes, Title 29, to the Joint Standing Committee on 27 Transportation and to the Second Regular Session of the 114th Legislature; and be it further 29 31 Allocation. Resolved: That the following funds are allocated from the Highway Fund to carry out the purposes of this resolve. 33 1988-89 35 SECRETARY OF STATE 37 **Division of Motor Vehicles** 39 All Other \$15,344 41 This allocation provides 43 funds for a contractual arrangement to recodify the 45 laws relating to motor vehicles. 47
