An Act to Establish a Residential Program for Adolescent Substance Abusers at Saint Mary's Hospital in Lewiston, Maine.



Be it enacted by the People of the State of Maine as follows:

Sec. 1. Adolescent rehabilitation center established. There is established a residential rehabilitation program for adolescent substance abusers at St. Mary's Hospital in Lewiston.

Sec. 2. Center purpose. The purpose of the program is to provide residential rehabilitation treatment of at least 6 months' duration to adolescent substance abusers who have been discharged from chemical dependency programs.

Sec. 3. Administration. The program shall be operated by St. Mary's Hospital and must comply with the standards for approved treatment facilities provided for in the Maine Revised Statutes, Title 22, chapter 1602, and must meet the requirements for obtaining a license provided for in Title 22, chapter 1663.

Sec. 4. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.
