1199, L.D. 1666, Bill, "An Act to Establish the Department of
Child and Family Services"

Amend the amendment by striking out all of the 2nd indented
paragraph after the title (page 1, lines 21 to 23 in amendment)
and inserting in its place the following:

'Further amend the bill by striking out everything after the
title and before the statement of fact and inserting in its place
the following:'

Further amend the amendment in Part A in section 2 in that
part designated "§203." in the first paragraph by inserting at
the end a new sentence to read:

'Members shall be appointed within 10 days of the effective date
of this chapter.'

Further amend the amendment in Part A in section 4 in the
3rd line (page 4, line 7 in amendment) by striking out the
following: "within 45 days of" and inserting in its place the
following: 'no later than 10 days after'

Further amend the amendment in Part B in section 1 in the
3rd line (page 4, line 18 in amendment) by striking out the
following: "October 1, 1991" and inserting in its place the
following: 'June 30, 1992'

Further amend the amendment in Part B in section 2 in the
3rd line (page 4, line 24 in amendment) by striking out the
following: "July 10," and inserting in its place the following:
'June 30,'

24 This amendment removes the emergency preamble and the
25 emergency clause, adjusts the dates to reflect the removal of the
26 emergency provisions, and specifies that the Children's Policy
27 Committee of the Committee for the Interdepartmental Coordination
28 of Services to Children and Families will be one of several
29 agencies to assist the Joint Select Committee on Families and
30 Children in developing the design of the department.
