21	'The inhabitants of the City of Biddeford do hereby indemnify, defend and hold harmless the State, its agents and employees with
23	respect to any cost or liability arising out of the management, ownership or administration of the premises or of the neighboring
25	property owned by the city.'
27	Further amend the resolve in the first resolve paragraph under the caption "PURCHASE AND SALES AGREEMENT" by striking out
29	the 4th paragraph (page 1, lines 33 to 36 in L.D.) and inserting in its place the following:

33	'(3) The grantee shall, at the time of closing, pay to the State, the sum of \$45,500 by certified or bank check payable to the Treasurer of the State of Maine. The grantee shall also,

Further amend the resolve by inserting before the statement of fact the following:

## **'FISCAL NOTE**

This resolve will result in the increase in dedicated 7 revenue to the Department of Conservation, Bureau of Public Lands, in the amount of \$45,500 for fiscal year 1989-90. This 9 increase in dedicated revenue will be derived from the proposed payment by the grantee to the State of Maine.'

## STATEMENT OF FACT

This amendment makes clear that the State is not to be held 17 liable for any problems on the parcel that is being transferred. 18 It also allows the State to collect \$45,500 for the parcel and 19 requires the City of Biddeford to pay costs associated with the sale of the property. 21

This amendment also adds a fiscal note.
