 Sec. 2 Description of lands. Resolved: That the department is authorized to take only land as needed for ownership of the Mattawamkeag Lake dam, flowage rights appurtenant thereto, access to the dam through a right-of-way and any land as needed for maintenance and repair.

This resolve includes the land in Township 4, Range 3, County of Aroostook, and State of Maine, to wit:

Beginning at an iron rod situated at the intersection of the 11 Bible Point Road and the Silver Ridge Road near the so-called Bible Point boat landing on the westerly shore of 13 the outlet of Mattawamkeag Lake in said Township 4, Range 3; thence South 74 degrees, 3 minutes, 50 seconds West, 558.7 15 feet along the centerline of said Bible Point Road to an iron rod; thence South 55 degrees, 2 minutes, 55 seconds 17 East, 728.0 feet to an iron rod located on the centerline of a road located on the easterly side of said Mattawamkeag River and Lake; thence North 33 degrees, 8 minutes, 55 19 seconds East, 329.8 feet along the centerline of said road 21 to an iron rod situated on the southerly boundary of land, now or formerly, leased by the Maine Forest Service; thence 23 North 38 degrees, 44 minutes, 20 seconds West, 122 feet to an iron rod situated on the east shore of said Mattawamkeag 25 Lake; thence North 39 degrees, 21 minutes, 25 seconds West, 257.6 feet to the point of beginning.

- Also conveying all right, title, and interest of the Grantor in and to the bed of Mattawamkeag Lake and the West Branch of the Mattawamkeag River as lies between the lines of the above described lot extending to the center of the bed of said lake and river.

COMMITTEE AMENDMENT "A" to H.P. 1247, L.D. 1740 1 **FISCAL NOTE** 3 5 It is anticipated that this legislation would result in no net fiscal impact to the Department of Inland Fisheries and 7 Wildlife for the biennium. Although the department expects to incur initial costs in carrying out the intent of the bill through the utilization of its Bond Account (#7665.1001), these 9 costs are expected to be reimbursed and credited to the 11 Department of Inland Fisheries and Wildlife.' 13 STATEMENT OF FACT 15 This amendment allows the Department of Inland Fisheries and Wildlife to acquire the Mattawamkeag Lake Dam by eminent domain 17 to clear any title problems, provided that there is a legal entity willing to compensate the department for the cost of 19 acquiring the dam. It also allows the dam to be leased by another party to take over responsibility for repairing, 21 maintaining and operating the dam. 23 Department of Inland Fisheries and Wildlife will The establish the water level and may require the lessee to construct 25 a fishway as part of the dam. 27
