24	1. Municipal officers; election; term. The municipal
26	officers from each county commissioner district shall choose the budget committee members by the following procedure.
28	A. Before September 15th of every year, the county
30	commissioners shall notify all municipal officers in the county to caucus by county commissioner districts at a
32	specified date, time and place for the purpose of electing at least one municipal officer from each district as a
34	member of the county budget committee except, in 1990, at least 3 municipal officers must be selected from each
36	district. The county commissioner shall serve as nonvoting moderator for that district caucus. Nominations must be
38	received from the floor. The nominee receiving the most votes is approved as a budget committee member except, in
40	1990, each caucus shall elect 3 members. The names of those elected by the caucus must be recorded and forwarded to the
42	county commissioners.
44	B. Budget committee members serve 3-year terms except, in 1990, one member from each district must be elected for a
