An Act to Amend the Procedure for Approval of the Lincoln County Budget.

(AFTER DEADLINE)



1	Be it enacted by the People of the State of Maine as follows:
3	30-A MRSA c. 3, sub-c. I, art. 5-A is enacted to read:
5	ARTICLE 5-A. LINCOLN COUNTY BUDGET
7	§791. Budget; appropriations; approval
9	Notwithstanding sections 2, 701 and 702, in Lincoln County the county commissioners may appropriate money, according to a
11	budget, which must be approved by a majority of the county commissioners.
13	§792. Interim budget
15	If the budget is not approved before the start of a fiscal
17	year, until a budget is finally adopted, the county shall operate on an interim budget which may not exceed 80% of the previous
19	year's budget.
21	§793. Advisory committee
23	There is established a Lincoln County Budget Advisory Committee comprised as follows.
25	1. Municipal officers. Municipal officers within each
27	commissioner district shall caucus and shall elect municipal officers from that district to fill vacancies as they arise, for
29	terms as provided in paragraph A.
31	A. Members shall serve for 3-year terms, except that initially each district caucus shall select one member for a
33	one-year term, one member for a 2-year term and one member for a 3-year term. There shall be 3 members from each
35	commissioner district. If a committee member ceases to be a municipal officer during the term of membership, the
37	<u>committee member shall resign the membership and the next</u> <u>district caucus shall elect a qualified municipal officer to</u>
39	fill the membership for the remainder of the unexpired term.
41	2. Legislative member. The Lincoln County legislative delegation shall select one of the delegation's members who is a
43	resident of Lincoln County to serve on the committee.
45	The committee shall select its own chair each year.
47	§794. Public hearing
49	The Lincoln County commissioners shall hold one or more

5	§795. Budget estimate; submission to advisory committee
7	The Lincoln County commissioners shall submit a budget

	estimate and make recommendations to the commissioners before
L1	November 15th. The county commissioners shall act on the budget
	in a timely fashion and, in any event, not later than December
L3	15th of the budget year.

L 7	A copy of the final budget estimates shall be filed, on
	forms approved by the Department of Audit, with the State
L 9	Auditor, who shall retain them for 3 years.
