17	Amend the bill by inserting at the beginning of the first line after the enacting clause (page 1, line 3 in L.D.) the
19	following: 'Sec. 1.'
21	Further amend the bill in that part designated " <u>5739.</u> " by striking out all of subsection 1 and inserting in its place the
23	following:
25	'1. Membership. The finance committee shall consist of 9
27	members, 3 members from each commissioner district elected as provided in this subsection. The county commissioners shall
29	<u>designate 3 district subdivisions within each district from each of which one member of the finance committee shall be elected.</u>
31	A. Finance committee members shall be elected on the Tuesday following the first Monday of November in each
33	even-numbered year. The election shall be conducted and the
35	results determined as provided for the election of county commissioners in section 61.
37	B. Before the first election of finance committee members,
39	the county commissioners shall designate 5 district subdivisions for which members of the finance committee
41	shall serve initial terms of 4 years, and 4 district subdivisions for which members of the finance committee
43	shall serve initial terms of 2 years. All subsequent terms are for 4 years. The county commissioners shall reapportion these subdivisions after each Federal Decennial Census.

47	<u>C. The finance committee shall annually elect a chair from among its members.</u>

1 D. A vacancy occurring on the finance committee shall be filled by the committee, subject to confirmation by a 3 majority of the county commissioners, for the balance of the unexpired term. The person appointed to fill the vacant 5 office must be from the same municipality or unorganized territory as the person vacating the office. 7 9 E. Members shall serve without compensation. 11 F. The county finance committee shall review and approve the budget and estimates, including the budget for municipal services in the unorganized territory prepared by the county 13 commissioners.' 15 Further amend the bill in that part designated "§739-A." in the first paragraph in the 2nd line (page 2, line 26 in L.D.) by 17 striking out the following: "the county courthouse" and inserting 19 in its place the following: 'county buildings' Further amend the bill in that part designated "§739-B." in 21 subsection 3 in the 7th line (page 3, line 16 in L.D.) by striking out the following "registered or certified" and in the 23 7th and 8th lines (page 3, lines 16 and 17 in L.D.) by striking out the following: "with return receipt requested" and in the 8th 25 and 9th lines (page 3, lines 17 and 18 in L.D.) by striking out the following: "with proof of receipt of the delivery," 27 Further amend the bill in that part designated "§739-B." in 29 subsection 5 in the last line (page 3, line 40 in L.D.) by striking out the following: "will" and inserting in its place the 31 following: 'shall' 33 Further amend the bill in that part designated "§739-C." in 35 the first paragraph in the 6th line (page 4, line 6 in L.D.) by striking out the following "Legislature" and inserting in its 37 place the following: 'finance committee' and in the 7th line (page 4, line 7 in L.D.) by striking out the following: "Legislature" and inserting in its place the following: 'finance 39 committee' and in the last line (page 4, line 10 in L.D.) by "Legislature" and inserting in its striking out the following: 41 place the following: 'finance committee' 43 Further amend the bill by inserting before the statement of 45 fact the following: 'Sec. 2. Effective date. This Act shall take effect for the 47

٦ STATEMENT OF FACT 5 This amendment makes the following changes to the bill. 7 The amendment provides for the popular election of the 1. 9 members of the finance committee. Three members will be elected from each county commissioner district, each representing a 11 subdivision of the commissioner district. Members will serve for 4-year terms, except that initially 5 are elected for 4-year terms and 4 are elected for 2-year terms. The finance committee 13 will elect a chair from among its members. Vacancies are filled by the finance committee, subject to confirmation by a majority 15 of the county commissioners. 17 2. The amendment provides that finance committee meetings need not be held solely in the county courthouse but may be held 19 in any county building. 21 The amendment deletes the requirement that the county 3. 23 obtain proof of delivery of the notice sent to each municipality regarding the proposed budget. 25 The amendment provides that the bill does not take 4. 27 effect unless the voters approve the recommendations of the Aroostook County Charter Commission. If approved by the voters 29 of Aroostook County, the finance committee members will be elected at the 1990 regular election and the finance committee 31 will begin reviewing county budgets with the 1992 budget. 33 Finally, the amendment makes various technical drafting 5. corrections to the bill.
