Resolve, to Modify the Kennebec County Budget .

(EMERGENCY) (After Deadline) **Emergency preamble. Whereas,** Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Kennebec County has certain expenses and liabilities that must be met as they become due; and

Whereas, the sums authorized as General Fund expenditures by the county in Resolve 1989, chapter 44, require some modification; and

Whereas, it is necessary that the taxes for the year 1989 in this resolve be immediately assessed in order to provide the required revenue for the county; and

Whereas, in the judgment of the Legislature, these facts 17 create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately 19 necessary for the preservation of the public peace, health and safety; now, therefore, be it
