HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to S.P. 680,
L.D. 1798, Bill, "An Act to Make Supplemental Appropriations and
Allocations for Expenditures of State Government and to Change
Certain Provisions of the Law Necessary to the Proper Operations
of State Government for the Fiscal Years Ending June 30, 1990,
and June 30, 1991"

Amend the amendment in Part A under the caption
"AGRICULTURE, FOOD AND RURAL RESOURCES, DEPARTMENT
OF" in that part relating to "Soil and Water Conservation
Commission" by inserting before the last sentence the
following: 'This appropriation shall not take effect until the
transfers described in Part L of this Act have taken place.'

Further amend the amendment in Part A under the caption
"DEFENSE AND VETERANS' SERVICES, DEPARTMENT OF" in
that part relating to "Administration - Maine Emergency
Management Agency" in the 6th line (page 3, line 47 in
amendment) by inserting after the following: "state" the
following: 'and local'

Further amend the amendment in Part A under the caption
"EXECUTIVE DEPARTMENT" in that part relating to
"Administration - Executive - Governor's Office" by striking out the
last 2 lines (page 8, lines 28 and 29 in amendment) and inserting
in their place the following:

**Division of Community Services -
Temporary Housing Assistance Program**

All Other \$250,000

Provides funds to be passed
through to the Community
Action Program (C.A.P.)
agencies for temporary
assistance for people who
need shelter or who are in
danger of becoming homeless

may include security
