### STATE OF MAINE

An Act Concerning the Commitment and Detention of Juveniles.



2	Be it enacted by the People of the State of Maine as follows:
2	15 MRSA §3205, as enacted by PL 1989, c. 571, Pt. A, §2, i
4	amended to read:
6	§3205. Juvenile in adult-serving jails

No juvenile may be committed or detained in an adult-serving jail after December 31, 1991 1999, except when bound over as an adult.

### STATEMENT OF FACT

The Bureau of Juvenile Corrections was established within the Department of Corrections by the First Regular Session of the 114th Legislature. The bureau is charged with separating adult and juvenile probation services no later than January 1, 2000. This bill makes separation of adult and juvenile offenders consistent with the date that the Department of Corrections must separate adult and juvenile probation services so that the State can have time to plan and pay for the cost of separation.
