HOUSE AMENDMENT "*A*" to COMMITTEE AMENDMENT "A" to H.P. 1421, L.D. 1973, Bill, "An Act to Protect Consumer Privacy by Regulating Automated Telephone Solicitations"

Amend the amendment in the first paragraph after the title in subsection 1 in paragraph B by striking out all of subparagraphs 3 to 5 and inserting in their place the following:

'(3) To promote or solicit charitable contributions; or

(4) To gather data or statistics or solicit information.'

Further amend the amendment by inserting after subsection 1 the following:

'Further amend the bill in that part designated "~~§1496.~~" in subsection 2 in the first and 2nd lines (page 1, lines 30 and 31 in L.D.) by striking out the following: ", partnership, corporation or association" '

Further amend the amendment by inserting after the 4th paragraph after the title the following:

'Further amend the bill in that part designated "~~§1496.~~" in subsection 3 in the first and 2nd lines (page 1, lines 44 and 45 in L.D.) by striking out the following: ", partnership, corporation or association" '

Further amend the amendment by inserting after the 9th paragraph after the title the following:

'Further amend the bill in that part designated "~~§1496.~~" in subsection 6 in paragraph B in the 2nd line (page 2, line 24 in L.D.) by striking out the following: "telephone" '
