SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to S.P. 769, L.D. 1994, Bill, "An Act to Provide for a Job Development Training Funding Capability within the Resources of the State Contingent Account"

Amend the amendment by striking out everything after the title and before the statement of fact and inserting in its place the following:

'Amend the bill by striking out all of section 1.

Further amend the bill in section 2 in subsection 5-A in the 2nd and 3rd lines (page 1, lines 50 and 51 in L.D.) by striking out the following: "~~sum~~ sums" and inserting in its place the following: 'sum'

Further amend the bill in section 2 in subsection 5-A in the 3rd and 4th lines (page 1, lines 51 and 52 in L.D.) by striking out the following: "~~\$1,000,000 \$1,075,000 in the fiscal year ending June 30, 1990, and \$1,000,000 in any fiscal year thereafter~~" and inserting in its place the following: '\$1,000,000'

Further amend the bill in section 2 in subsection 5-A in the 8th line (page 2, line 3 in L.D.) by inserting after the following: "industries." the following: 'In fiscal year 1989-90 \$75,000 of this amount may also be allocated for immediate job training, unemployment counseling, retraining and other assistance to displaced workers.'

Further amend the bill by striking out all of section 3 and inserting in its place the following:

**'Sec. 3. Quarterly reports.** The Commissioner of Economic and Community Development and the Commissioner of Labor shall submit quarterly reports to the Joint Standing Committee on Appropriations and Financial Affairs detailing the expenditure of funds pursuant to section 1 of this Act.' '

Further amend the bill by renumbering the sections to read consecutively.

**STATEMENT OF FACT**
