Whereas, Acts of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 4 Whereas, the Legislature recently initiated the development 6 and funding of services to people who are infected with the HIV virus; and 8 Whereas, it is essential to ensure the continued provision 10 of these vital services; and Whereas, without immediate action, services to persons 12 infected with the HIV virus may be reduced; and 14 Whereas, in the judgment of the Legislature, these facts .16 create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 18 safety; now, therefore, 20 Be it enacted by the People of the State of Maine as follows: 22 Appropriation.
