SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to S.P. 841, L.D. 2160, "Resolve, to Study Threats to Maine Lakes"

Amend the amendment in the first indented paragraph after the title in the 2nd line (page 1, line 17 in amendment) by striking out the following: "emergency clause" and inserting in its place the following: 'statement of fact'

Further amend the amendment by striking out all of section 9 and inserting in its place the following:

'Sec. 9. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
