20	'Sec. 10. Application. The Maine Revised Statutes, Title 24, section 2349 and Title 24-A, section 2849-B, apply to all
22	policies, contracts and certificates executed, delivered, issued for delivery, or renewed in this State on or after April 1, 1991,
24	and to all policies, contracts and certificates in force on April 1, 1991. All policies, contracts and certificates in force on
26	April 1, 1991, must provide coverage effective April 1, 1991, to individuals who were previously denied coverage, but who would
28	have received coverage had Title 24, section 2349 and Title 24-A, section 2849-B been in effect on the date the individuals became
30	eligible to enroll in the plan. Title 24, section 2350 and Title 24-A, section 2850 apply to all policies and contracts executed,
32	delivered, issued for delivery, or renewed in this State on or after December 1, 1990. All other provisions of this Act apply
34	to all policies, contracts and certificates executed, delivered, issued for delivery, or renewed in this State on or after October
36	1, 1990. For purposes of this Act, all contracts are deemed to be renewed no later than the next yearly anniversary of the
38	contract date.'

Further amend the amendment in section 11 by striking out all of subsection 5 (page 13, lines 39 to 41 in amendment) and inserting in its place the following:

'5. The task force shall submit any recommendations for legislation to the First Regular Session of the 115th Legislature and to the Office of the Executive Director of the Legislative Council by December 1, 1990.'
