IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND NINETY

Resolve, to Extend the Deadline for the Report of the Commission on Maine's Future.

(EMERGENCY). (AFTER DEADLINE) **Emergency preamble. Whereas,** Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Commission on Maine's Future was created by 6 Resolve 1987, chapter 60, which contains deadlines the commission is obligated to meet; and

Whereas, in view of the changing fiscal situation within 10 State Government, as well as the unanticipated changes in eastern Europe, which have important implications to Maine's economic 12 future, it is necessary to extend the deadlines to allow the Commission on Maine's Future to plan and develop further the 14 proposals of the commission in a timely manner; and

16 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of 18 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 20 safety; now, therefore, be it

Sec. 1. Resolve 1987, c. 60, 2nd resolve clause, 2nd paragraph, 2nd sentence amended. Resolved: That Resolve 1987, c. 60, 2nd resolve
clause, 2nd paragraph, 2nd sentence, as amended by Resolve 1989, c. 3, is further amended to read:

The commission members shall serve terms to expire on May-1 June 30, 1990, to enable the commission to advise the Legislature with respect to the proposals and to follow the implementation of the proposals of the commission.
