An Act to Limit the Liability of Sponsors of Equine Activities.

	Be it enacted by the People of the State of Maine as follows:
2	14 MRSA §169 is enacted to read:
4	§169. Limitations on liability for equine activities

8	1. Definitions. As used in this section, unless the context otherwise indicates, the following terms have the
10	following meanings.
10	<u>A. "Equine" means a horse, pony, mule, donkey or hinny.</u>
12	B. "Equine activity" means any one or more of the following:
14	(1) Equine shows, fairs, competitions, performances or
16	parades that involve any breeds of equines, and any of the equine disciplines, including, but not limited to,
18	dressage, hunter and jumper horse shows, grand prix jumping, 3-day events, combined training, rodeos,
20	driving, pulling, cutting, polo, steeplechasing, endurance trail riding, western games and hunting;
22	(2) Equine training or teaching activities;
24	(3) Boarding equines;

28	(4) Riding, inspecting or evaluating an equine belonging to another whether or not the owner has
30	<u>received some monetary consideration or other thing of</u> value for the use of the equine or is permitting a
32	<u>prospective purchaser of the equine to ride, inspect or</u> evaluate the equine; and
34	<u>(5) Rides, trips, hunts or other equine activities of any type, however informal or impromptu, that are</u>
36	sponsored by an equine activity sponsor.
38	<u>C. "Equine activity sponsor" means an individual, group, club, partnership or corporation, whether operating for</u>
40	profit or nonprofit, that sponsors, organizes or provides the facilities for an equine activity, including, but not
42	limited to, pony clubs; 4-H clubs; hunt clubs; riding clubs; classes or programs sponsored by a school or college;
44	therapeutic riding programs; and operators, instructors and
46	<u>promoters of equine facilities, including, but not limited</u> <u>to, stables, clubhouses, ponyride strings, fairs and arenas</u> <u>at which the activities are held.</u>

50	<u>D. "Participant" means any person, whether amateur or</u> professional, who directly engages in an equine activity,

whether or not a fee is paid to participate in the equine activity.

"Engages in an equine activity" means a person who 4 Е. rides, trains, drives or is a passenger upon an equine, whether mounted or unmounted, and does not mean a spectator 6 at an equine activity or a person who participates in the equine activity but does not ride, train, drive or ride as a 8 passenger upon an equine. 10 F. "Equine professional" means a person engaged for 12 compensation: (1) In instructing a participant or renting to a 14 participant an equine for the purpose of riding, 16 driving or being a passenger upon the equine; or 18 (2) In renting equipment or tack to a participant. 20 2. Immunity for sponsor or equine professional. An equine activity sponsor or an equine professional is immune from civil 22 liability for an injury to, or the death of, a participant engaged in an equine activity and, except as provided in 24 subsection 3, a participant or a participant's representative may not maintain an action against an equine activity sponsor or an 26 equine professional for an injury to, or the death of, a participant engaged in an equine activity. 28 3. Exceptions. Nothing in this section applies to the 30 horse racing industry, or prevents or limits the liability of an equine activity sponsor or an equine professional: 32 A.
