30	This bill provides General Fund appropriations to continue the Surname Index Project. Appropriations beyond fiscal year
32	1992-93 may be required to finish the project.'

36	STATEMENT OF FACT
38	This amendment provides funding through the Maine State Library for the continuation of the Surname Index Project. The
40	Surname Index Project is a mostly volunteer project begun in 1970 to catalog and record genealogical and historical data about
42	Maine people, especially early settlers. The amendment changes the fiscal year 1991-92 appropriation to provide for the one-time
44	costs of purchasing computer hardware and software for the project and adds an appropriation for fiscal year 1992-93 for
46	personnel and supplies for the project. It is anticipated the project will take at least 2 years to complete.
48	
50	The Genealogical Society of Utah has made a commitment to microfilm the genealogical and historical data collected by the Surname Index Project at no expense to this State. The
52	approximate value of this microfilming is \$200,000. A copy of
