Amend the bill in Part I in that part designated "§13120." in the 2nd line (page 124, line 50 in L.D.) by striking out the following: "Development" and inserting in its place the following: 'Services'

Further amend the bill in Part I in section I-11 in subsection 1 in the first line (page 135, line 29 in L.D.) by striking out the following: "Development" and inserting in its place the following: 'Services'

Further amend the bill in Part I in section I-11 in subsection 6 in the 4th and 5th lines (page 136, lines 32 and 33 in L.D.) by striking out the following: ", Office of Community Development"

Further amend the bill in Part I in section I-11 in subsection 8 in paragraph A in the 4th and 5th lines (page 138, lines 14 and 15 in L.D.) by striking out the following: ", Office of Community Development"

Further amend the bill in Part I in section I-11 in subsection 9 in the 4th line (page 138, line 34 in L.D.) by striking out the following: ", Office of Community Development"

Further amend the bill in Part I in section I-15 in the first line (page 140, line 33 in L.D.) by striking out the figure "I-5" and inserting in its place the following: 'I-4'

Further amend the bill in Part X in section X-2 in that part designated "§15193." in the first paragraph in the 5th line from the end (page 258, line 6 in L.D.) by inserting after the

2 following: "effectively" the following: 'to advise, consult and
3 assist with implementing this chapter'

4 Further amend the bill in Part X in section X-2 in that part
5 designated "§15193." in subsection 1 in the 8th line (page 258,
6 line 19 in L.D.) by striking out the following: "If" and
7 inserting in its place the following: 'To the fullest extent'

8 Further amend the bill in Part X in section X-2 in that part
9 designated "§15193." in subsection ~~2~~ in paragraph A in the 2nd
10 line (page 258, line 32 in L.D.) by striking out the following:
11 "no" and inserting in its place the following: 'not'

12 Further amend the bill in Part X in section X-3 in
13 subsection 4 by striking out all of the first sentence (page 259,
14 lines 26 to 34 in L.D.) and inserting in its place the following:

15 'To facilitate the transition process, it is the intent of
16 the Legislature that the proposed departments exist with a
17 limited purpose, and that by May 1, 1991 interim commissioners be
18 appointed; the legislative committee appointed under section X-5
19 of this Act begin its work; and members of the Maine Commission
20 on Families, Health and Rehabilitation, appointed pursuant to
21 Title 5, section 15193, subsection 1, and officials of the
22 executive branch begin work in earnest to fulfill the intent of
23 this Act.'

24 Further amend the bill in Part X in section X-3 in
25 subsection 5 in the 8th line (page 260, line 2 in L.D.) by
26 striking out the following: "this section" and inserting in its
27 place the following: 'Part X of this Act'

28 Further amend the bill in Part X in section X-7 by striking
29 out all of the last 4 lines (page 261, lines 47 to 50 in L.D.)
30 and inserting in their place the following:

31 'Provides funds to carry out the purposes of
32 this Part.'
