Constitutional amendment. RESOLVED: Two thirds of each the Legislature concurring, that the following branch of amendment to the Constitution of Maine be proposed:

Constitution, Art. IX, §21 is enacted to read:

Section 21. Prohibition of state mandates; reimbursement of certain state mandates. The Legislature, Executive Department or 8 any agency of the State may not repeal; amend or enact a law or rule that imposes a new or expanded requirement on a local unit 10 of government if that requirement causes an expenditure by a 12 combination of local units of government or a single local unit of government in excess of \$100,000 per year, unless the Legislature annually reimburses those local units for those 14 expenditures.

PROFESTIONAL Constitutional referendum procedure; form of question; effective 20 date. Resolved: That the city aldermen, town selectmen and bit inplantation assessors of this State shall notify the inhabitants of their respective cities, towns and plantations to meet, in the 22 manner prescribed by law for holding a statewide election, at a statewide election, on the Tuesday following the first Monday of 24 November following the passage of this resolution, to vote upon 26 the ratification of the amendment proposed in this resolution by voting upon the following question:
