An Act to Provide Free Hunting, Trapping and Fishing Licenses to Members of the Armed Forces.

	Be it enacted by the People of the State of Maine as follows:

4	Sec. 1. 12 MRSA §7071, sub-§4, as amended by PL 1987, c. 351, is repealed.
6	Sec. 2. 12 MRSA §7071, sub-§4-A is enacted to read:
8	4-A. Families of members of United States Armed Forces
	stationed in State. The spouse and children of a member of the
10	United States Armed Forces permanently stationed in the State who permanently reside with that member, are eligible for any
12	trapping, fishing, hunting or combination fishing and hunting license or permit at the resident fee and have the same
14	privileges as Maine residents in regard to trapping, hunting and fishing.

18	<u>An application for a license under this subsection must be accompanied by certified evidence of the spouse's and children's</u>
20	permanent residence with a member of the United States Armed Forces who is permanently stationed at a post, station or base in the State. The clerk or agent of the town in which that military
22	or naval post, station or base is situated shall issue the licenses and permits.

This bill provides a complimentary hunting, fishing and trapping license to active members of the United States Armed Forces. The bill also updates language concerning issuance of licenses to families of those members.
