4. Possession of useful objects. Except as otherwise directed by the Attorney General, his the Attorney General's deputies or his assistants, the medical examiner or Office of the Chief Medical Examiner may direct that a law enforcement officer
at the scene make measurements, take photographs and take possession of all objects which that in the medical examiner is opinion of the medical examiner or Office of the Chief Medical Examiner and take a possession of all objects which that is the medical examiner is opinion of the medical examiner or Office of the Chief Medical Examiner may be useful in establishing the cause and, manner and circumstances of death.'

STATEMENT OF FACT

The bill relates to the powers and duties of law enforcement officers to assist in the investigation of a death when the medical examiner does not proceed to the scene of the death. The amendment rewords the part of the bill relating to investigations by law enforcement officers without changing the substance of the bill.
