	This amendment, which is the majority report of the Joint
30	Standing Committee on Fisheries and Wildlife, strikes the
32	language of the original bill and replaces it with language that lowers the ice fishing line limit on Class B waters from 5 lines
72	to 3 lines. The amendment allows the Commissioner of Inland
34	Fisheries and Wildlife to set a different line limit not to
	exceed 5 lines. This provision is repealed on June 30, 1993.
