Be it enacted by the People of the State of Maine as follows:

35-A MRSA §114, sub-§3, as enacted by PL 1987, c. 141, Pt. A, §6, is amended to read:

6 In camera inspection. Upon request by the commission 3. staff, the Public Advocate or intervenor in a matter before the 8 commission or upon the commission's own motion and for good cause shown, the commission may order a public utility to produce for 10 in camera inspection by the commission or hearing examiner the records designated confidential under subsection 1, paragraph A. 12 The employee whose records are the subject of such a request shall must be notified by the commission of the request and shall 14 must be given the opportunity to be heard before an order to If the commission or hearing examiner produce is issued. 16 determines after in camera inspection that a record is reasonably relevant to the matter before it and that production of the 18 record is not unjust or unlawful and that the materiality of the record outweighs any harm to the employee from its disclosure, 20 the commission or hearing examiner may order that the record be made a part of the discovery or evident aspects of the 22 proceedings, subject to the terms and conditions that are just, due consideration being given to the privacy interests of the 24 employee involved.

26 The record designated confidential under subsection 1, paragraph B may not be subject to in camera inspection or disclosure unless
28 such inspection or disclosure is required by order of the Superior Court.

STATEMENT OF FACT

This bill protects certain personnel records of utility 36 employees. This bill will protect personal and private records from disclosure as well as ensure complete and candid evaluations 38 of utility personnel.
