Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted 2 as emergencies; and 4 Whereas, it is necessary that the provisions of journeyman-in-training electricians' licensing laws be continued 6 without interruption; and 8 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately 10 necessary for the preservation of the public peace, health and 12 safety; now, therefore, 14 Be it enacted by the People of the State of Maine as follows: 16 32 MRSA §1202, sub-§1, ¶D, as repealed and replaced by PL 1989, c. 878, Pt. A, \$92, is amended to read: 18 D. D. For a journeyman-in-training electricians: electrician's license, a person must be a graduate of an accredited Maine 22 technical college electrical program or a vocational-electrical program of the Department of Corrections, receive a passing grade on the journeyman 24 examination and complete 2,000 hours of experience. This provision-shall-be-reviewed-by-the-joint-standing-committee of -- the -- Legislature -- having -- jurisdiction -- over -- business legislation-by-March-1,-1991,-and,-unless-continued_by-law, shall-terminate-at-this-time-Emergency clause.
