SENATE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to H.P. 14 654, L.D. 928, Bill, "An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government and to 16 Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 18 30, 1992 and June 30, 1993"

Amend the amendment by inserting at the end before the emergency clause the following:

## **PART K**

Sec. K-1. New positions eliminated. Notwithstanding any other provision of this Act, all newly-created General Fund positions and all positions that are currently vacant but still funded in this Act are eliminated. No salary and benefits savings accruing as a result of this Part may be used for any other purpose.

Sec. K-2. Calculation and transfer. The State Budget Officer shall calculate the amount in section 3 of this Part that applies against each General Fund account for all departments and agencies based on the authorization of portions elsewhere in this Act. Notwithstanding Title 5, section 1585, the State Budget Officer shall cause the calculated amount to be transferred from each account.

Sec. K-3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Part.
