 COMMITTEE AMENDMENT "A" to H.P. 656, L.D. 935, Bill, "An
 14 Act Requiring School Districts to Make Instruction in Braille Reading and Writing Available to Blind Students"

Amend the bill by striking out all of the title and 18 substituting the following:

20 'An Act to Incorporate Braille Reading and Writing in a Blind Student's Individual Education Plan'

Further amend the bill in the first line after the enacting 24 clause (page 1, line 3 in L.D.) by inserting at the beginning the following: 'Sec.1.'

Further amend the bill in that part designated "54708." in subsection 1 by striking out all of paragraph A.

30 Further amend the bill in that part designated "§4708." in subsection 1 by relettering the paragraphs to read consecutively.

Further amend the bill in that part designated "<u>§4708.</u>" by 34 striking out all of subsections 2 to 4 and inserting in their place the following:

 '2. Level of instruction; individualized education plan.
 Instruction in Braille reading and writing for a student who has been evaluated as needing Braille through the individualized
 education plan should be sufficient to enable each student to communicate effectively and efficiently at that student's
 intellectual level. The individualized education plan for each student who has been evaluated as needing Braille must specify:

A. The method of implementation utilizing Braille as a primary mode of learning through integration with normal classroom activities; and

6	3. Certification. The department shall report to the joint standing committee of the Legislature having jurisdiction over
8	education matters by January 15, 1992 on the status of national efforts to certify teachers of blind and visually impaired
10	students.
12	Sec. 2. 20-A MRSA §7201, sub-§5 is enacted to read:
14	5. Blind students; Braille instruction. All students may receive instruction in Braille reading and writing as part of
16	their individualized education plans. A student may not be denied the opportunity of instruction in Braille reading and
18	writing solely because the student has some remaining vision. If Braille is not provided to a child who is blind, the reason for
20	not incorporating Braille in the individualized education plan must be documented in the individualized education plan.

24	FISCAL NOTE
26 28	This bill requires the Department of Education to report to the Legislature on the status of national efforts to certify teachers of blind and visually impaired students. The costs
30	associated with this report can be absorbed within current budgeted resources of the Department of Education.'

34	STATEMENT OF FACT
36	This amendment does the following:
38	1. Deletes the definition of "blind";
40	2. Moves the language concerning the availability of
42	Braille instruction to the Maine Revised Statutes, Title 20-A, chapter 303 and adds a provision requiring that the
44	individualized education plan of a blind student not receiving Braille instruction include a statement explaining why;
46	3. Limits the provisions concerning the level of instruction in Braille to students who have been evaluated as
48	needing instruction in Braille to students who have been evaluated as needing instruction in Braille through the individualized education plan and changes the level of instruction provision
50	from a requirement to a suggestion;

 B January 15, 1992 to the Joint Standing Committee on Education on the status of national efforts to certify teachers of the blind;
