COMMITTEE AMENDMENT " A." to S.P. 399, L.D. 1075, Bill, "An Act to Allow the Suspension of Fines in Certain Cases"

Amend the bill by striking out everything after the enacting clause and before the statement of fact and inserting in its place the following:

'17-A MRSA §1152, sub-§2, ¶C, as amended by PL 1989, c. 502, Pt. D, §10, is further amended to read:

C. A fine, suspended in whole or in part, with, at the court's discretion, probation as authorized by chapter 49;'

STATEMENT OF FACT

This amendment clarifies that the court may, but is not required to, impose probation when it sentences a person to pay a fine and suspends part or all of the fine.
