18	clause and before the statement of fact and inserting in its
20	place the following:

22	is amended to read:
24	3. Local participation in siting decision. Within 60 days
26	of the final selection by the authority of the low-level waste disposal facility site, the governing body of the municipality
20	where the facility is to be located, or the Secretary of State in
28	the case of an unorganized township, shall hold an election for the purpose of approving the site. Unless 60% of the voters
30	casting ballots in the election approve of the authority's site
	location decision, the authority shall may not locate the
32	facility within the municipality or territory. <u>After January 1,</u> 2001, the authority may not site a low-level radioactive waste
34	storage facility, or continue to operate any previously sited
36	<u>low-level radioactive waste storage facility, without the approval of at least 60% of the voters of the host municipality</u>
	or township.

40	FISCAL NOTE
42	This bill requires voter approval of selected low-level
	radioactive waste disposal sites after January 1, 2001. There is
44	an undetermined future cost to the Department of the Secretary of State of holding elections; the cost of which will depend upon
46	the sites selected. Pursuant to the Maine Revised Statutes,
48	Title 38, section 1534, subsection 2, these costs will be paid from the Low-level Radioactive Waste Facility Fund.'

10 the approval of at least 60% of the voters of the host municipality or township.
