IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND NINETY-ONE

An Act to Improve Services to At-risk, Pregnant and Parenting Teens.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 19 MRSA §514, as amended by PL 1989, c. 702, Pt. E, $\S8$, is further amended to read:

§514. Dedicated funds

8 All collections, fees and incentive payments received by the department from child support collections must be dedicated to reduce the State's General Fund share of Aid to Families with 10 Dependent Children and, to cover the costs of making such 12 collections and to fund programs for teen parents. The department may not expend more than \$1,800,000 in fiscal year 14 1989-90 and \$2,654,000 in any fiscal year thereafter of incentive payment revenue for the purpose of covering the costs of making child support collections. The department may not expend more 16 than \$1,000,000 in fiscal year 1991-92 and in any fiscal year thereafter of incentive payment revenue for the purpose of 18 funding programs for teen parents.

Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.
