HOUSE AMENDMENT "" to COMMITTEE AMENDMENT "A" to H.P. 787,
14 L.D. 1119, Bill, "An Act to Authorize a General Fund Bond Issue in the Amount of \$15,000,000 to Help Municipalities with the
16 Purchase of Equipment and Construction Costs for Solid Waste Disposal and Recycling Facilities"

Amend the amendment by striking out all of the first 20 paragraph after the title (page 1, lines 19 to 25 in amendment) and inserting in its place the following:

'Amend the bill by striking out all of the title and 24 substituting the following:

'An Act to Authorize a General Fund Bond Issue in the Amount of \$10,000,000 to Help Municipalities with the Purchase of Equipment and Construction Costs for Solid Waste Disposal and Recycling Facilities' '

Further amend the amendment in the 2nd paragraph after the 32 title in the last line (page 1, line 29 in amendment) by striking out the following: "\$9,000,000" and inserting in its place the 34 following: '\$10,000,000'

Further amend the amendment on page 2 in the 3rd line (line 5 in L.D.) by striking out the following: "\$4,000,000" and inserting in its place the following: '\$5,000,000' and by striking out all of the 12th line (line 16 in amendment) and inserting in its place the following:

Further amend the amendment in the 2nd paragraph from the end before the fiscal note in the last line (page 2, line 21 in amendment) by striking out the following: "\$9,000,000" and inserting in its place the following: '\$10,000,000' HOUSE AMENDMENT " to COMMITTEE AMENDMENT "A" to H.P. 787, L.D. 1119

2 Further amend the amendment in the fiscal note by striking out all of the first paragraph (page 2, lines 28 to 30 in amendment) and inserting in its place the following: 4

'The total cost of this bond issue is estimated to be б \$13,355,000 with principal payments of \$10,000,000 and interest 8 payments of approximately \$3,355,000.'
