STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND NINETY-ONE

An Act to Place Certain Lands Recommended by the Special Committee on the New Capitol Area Master Plan under the Jurisdiction of the Capitol Planning Commission.

Be it enacted by the People of the State of Maine as follows:

1 MRSA §814, as amended by PL 1989, c. 502, Pt. A, §1, is further amended to read:

6 §814. Purchase of real estate

Whenever the Governor determines that public exigencies require the construction of additional buildings, structures, parking spaces or other facilities for the expansion of State Government in the Capitol Area, he <u>the Governor</u> may purchase or take by eminent domain real estate in Augusta. The Capitol Area is as defined in <u>as</u> the following description; described premises.

1. West side of Kennebec River

Beginning at the intersection of the easterly line of 1.8 Florence Street with the northerly line of Capitol Street; thence easterly along said northerly line of Capitol Street to a point 20 of 150 feet westerly of the intersection of the westerly line of Federal Street projected northerly across said Capitol Street and 22 said northerly line of Capitol Street; thence southerly and parallel to said westerly line of Federal Street about 800 feet to Kennedy Brook; thence following the thread of the stream 24 generally easterly to its intersection with the northerly 26 property line of the land of the State of Maine, being part of the Motor Vehicles premises; thence westerly about 60 feet along said property line; thence southerly along said property line 28 about 155 feet; thence easterly along said property line about 30 140 feet; thence southerly along said property line about 120 feet to the northerly line of Manley Street; thence diagonally 32 and southwesterly across Manley Street to its intersection with the northwesterly corner of other land of the State of Maine, thence southerly along said property line extended to 34 the northerly line of Glenwood Street; thence along said Glenwood Street easterly to the westerly line of State Street; thence 36 northerly along said State Street about 150 feet to a point 38 opposite the northerly line of Britt Street; thence across State Street and along the northerly line of said Britt Street easterly 40 to its intersection with property of Augusta Sanitary District; thence northerly and easterly as said property line may run to its intersection with the westerly-right-of-way-line-of-the-Maine-42 Gentral--Railroad--Company Kennebec River; thence along said 44 railread--line river northerly as the same may run to its intersection with the southerly line of highway Route 201; thence 46 southwesterly along said highway line, as the same may run, to the easterly line of State Street at its intersection with thence across State Street in a 48 Memorial Traffic Circle; northwesterly direction to the southeasterly line of Grove Street 50 at its intersection with Memorial Traffic Circle; thence southwesterly along said Grove Street to the northerly line of

Higgins Street; thence across Grove Street; thence southerly along Grove Street to its intersection with the northerly line of Wade Street; thence westerly about 400 feet in a straight line along Wade Street and its northerly line extended to the westerly line of Sewall Street; thence southerly along Sewall Street to the northerly line of Wade Street; where it intersects the westerly line of Sewall Street; thence westerly along the northerly line of Wade Street, and thence continuing in a straight line westerly and parallel to Capitol Street to the easterly line of Florence Street; thence southerly along Florence Street to the point of beginning. pated entire bits

Beginning at a point in the westerly line of Sewall Street 14 at the junction of said westerly line of said Sewall Street and the southerly line of Blaisdell Street; thence westerly along the southerly line of Blaisdell Street 588 feet more or less to a 16 point; thence S 24° 29' 55" W 2,194 feet to a point in the City 18 of Augusta and City of Hallowell line; thence N 60° 10' 58" W 1,713.92 feet to a point in the southerly line in said city line; thence N 30° 24' 15" E 90.75 feet; thence N 60° 10' 58" W 850 20 feet more or less to a point; thence N 34° 24' 14" E 1,550 feet more or less to a point at the southwest corner of the Bouchard 22 lot, book 2566, page 36, Kennebec County Registry of Deeds; 24 thence N 89° 18' 40" E 500 feet more or less to a point in the easterly line of Ganneston Drive; thence continuing the same course from the easterly line of Ganneston Drive a distance of 26 500 feet to a point; thence northerly and parallel to Ganneston 28 Drive to a point in the southerly line of Berwick Road said point being 500 feet easterly of the junction of said drive and road; thence southeasterly along the southerly line of Berwick Road to 30 a point at the junction of said road and the northeasterly line of Town and Country Road; thence northeasterly along the easterly 32 line of Town and Country Road to a point at the junction of said road and the southerly line of Capitol Street; thence 34 southeasterly along the southerly line of Capitol Street to a point 150 feet westerly of the intersection of the westerly line 36 of Federal Street and said northerly line of Capitol Street; 38 thence southerly and parallel to said line of Federal Street about 800 feet more or less to Kennedy Brook; thence following the thread of the stream generally easterly to its intersection 40 with the northerly line of Sewall Street; thence southwesterly 42 along the westerly line of Sewall Street to the place of beginning. worked tothe follows were out to an affined
