COMMITTEE AMENDMENT "A" to H.P. 940, L.D. 1362, "Resolve, to Develop Evidence Protocols and Standardized Kits for Cases of Alleged Gross Sexual Misconduct"

Amend the resolve by striking out the title and substituting the following:

'Resolve, to Develop Evidence Protocols and Standardized Kits for Cases of Alleged Gross Sexual Assault'

Further amend the resolve in the 2nd paragraph in the 2nd line (page 1, line 6 in L.D.) by striking out the following: "misconduct" and inserting in its place the following: 'assault'

Further amend the resolve in the 3rd paragraph in the last line (page 1, line 11 in L.D.) by striking out the following: "misconduct" and inserting in its place the following: 'assault'

Further amend the resolve in the 4th paragraph in the last line (page 1, line 15 in L.D.) by striking out the following: "misconduct" and inserting in its place the following: 'assault'

Further amend the resolve in section 1 in the 3rd line (page 1, line 25 in L.D.) and in the next to the last line (page 1, line 27 in L.D.) by striking out the following: "misconduct" and inserting in its place the following: 'assault'

Further amend the resolve by inserting at the end before the statement of fact the following:

This resolve requires the Department of Public Safety and the Department of Human Services to propose a standardized kit for the collection of evidence for cases of alleged gross sexual assault. The Department of Public Safety will absorb the costs associated with the review and proposal of a kit and submitting a
