26	striking out all of paragraph F (page 3, lines 13 to 46 in L.D.) and inserting in its place the following:
28	'F. Debits and carry-overs are <u>must be</u> determined as follows.

	(1) Except as provided in subparagraph (2), the
32	commission shall debit against the Hespital <u>Certificate</u> <u>of Need</u> Development Account the full amount of the
34	incremental annual capital and operating costs associated with each project for which an adjustment is
36	approved under paragraph C <u>and with each project for</u> which certificate of need approval has been granted
38	pursuant to section $304-A$ , subsection 2. Incremental annual capital and operating costs are must be
40	determined in the same manner as adjustments to financial requirements are determined under section
42	396-D, subsection 5, for the 3rd year of implementation
44	of the project projects subject to such an adjustment. For acquisitions of equipment by persons other than
