- 'Sec. 1. 7 MRSA §530, sub-§4, as enacted by PL 1989, c. 527, §1, is amended to read:
- 4. Educational program. The Subject to available funding,

 8 the department shall institute an educational program designed to inform the general public about this section. This program shall next include, but not be limited to, dissemination of information about the countries and produce affected and the pesticides, residues and known and potential adverse health effects of those pesticides. This dissemination shall must be made by at least the following:
- A. Brochures to be made available to consumers through retail outlets; and
- B. Media coverage, such as public service announcements, press releases and press conferences.'
- Further amend the amendment by inserting after section 1 the following:
- 'Sec. 2. 7 MRSA §1033, sub-§2, ¶I, as enacted by PL 1989, c. 459, §2, is amended to read:
- I. To promote, in cooperation with the commissioner, a voluntary program of variety labeling for Maine bags and other consumer packs of potatoes. This--paragraph--is repealed-July-1,-1991.

'FISCAL NOTE

The Department of Agriculture, Food and Rural Resources will absorb the costs associated with adopting rules and enforcing the provisions of the country of origin labeling laws and the labeling of produce treated with post-harvest treatments laws utilizing existing budgeted resources. The bill requires the department to institute an educational program under the country of origin laws utilizing only available funds. The department will not need additional resources to continue the potato variety labeling program and the antitheft blueberry laws.

The additional work load and administrative costs associated with the minimal number of additional cases filed in District Court as a result of the violation will be absorbed within the budgeted resources of the Judicial Department. The collection of additional fines will increase General Fund revenue by a minor amount.'

STATEMENT OF FACT

This amendment changes the title of the bill. The amendment repeals additional sunset provisions. The sunset on the potato variety labeling program is repealed. The sunset on laws enacted to reduce the theft of blueberries is repealed. Both have sunset dates of July 1, 1991.

The amendment also amends the requirement that the Department of Agriculture, Food and Rural Resources institute an educational program under the country of origin labeling laws by requiring that program only if funds are available within the reserves of the department. The amendment also deletes the appropriation and replaces the fiscal note.
