## STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND NINETY-ONE

An Act to Clarify the Role of the Maine Youth Center.

#### Be it enacted by the People of the State of Maine as follows:

Sec. 1. 34-A MRSA §3802, sub-§2, as enacted by PL 1983, c. 459, §6, is amended to read:

2. Accomplishment. To accomplish the purposes set out in subsection 1, the disciplines of education, casework, group work, psychology, psychiatry, medicine, nursing, vocational training and religion as they are related to human relations and personality development shall <u>must</u> be employed. <u>Security</u> <u>measures, whether in the form of physically restrictive</u> <u>construction or intensive staff supervision, when appropriate,</u> <u>must be taken to accomplish these purposes.</u>

Sec. 2. 34-A MRSA §3805, as amended by PL 1983, c. 581, §§47 and 59, is further amended to read:

1. Eligibility. Only a juvenile, as defined in Title 15, section 3003, subsection 14, who is 11 years of age or older at the time of the-court's-disposition-of-the-ease detention or commitment may be detained at or committed to the center pursuant to this subchapter and Title 15, Part 6.

26 2. Limitations. No person may be <u>detained at or</u> committed to the center who is blind or who is a proper subject for any
28 state institution administered by the Department of Mental Health and Mental Retardation.

3. Certification. When a person is <u>detained at or</u>
 32 committed to the center, the court making the <u>detention or</u> commitment shall certify on the mittimus the person's birthplace,
 34 parentage and legal residence.

#### STATEMENT OF FACT

This bill clarifies the role of the Maine Youth Center in 2 ways. The Maine Revised Statutes, Title 34-A, section 3802, subsection 2 is amended to clarify that security measures may be imposed to accomplish rehabilitation and Title 34-A, section 3805 is amended to reflect that the Maine Youth Center is not appropriate for the holding of young or mentally disabled juveniles.
