COMMITTEE AMENDMENT "A" to H.P. 1174, L.D. 1715, Bill, "An Act to Establish State Selective Purchasing Standards"

Amend the bill by inserting after section 6 the following:

'Sec. 7. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

14 This bill prohibits all state agencies from purchasing goods  
or entering into contracts with individuals or companies  
16 operating in South Africa. The Department of Administration,  
Bureau of Purchases, will require General Fund appropriations of  
18 \$17,494 in fiscal year 1991-92 and \$750 in fiscal year 1992-93 in  
order to promulgate rules, screen approximately 1,600 vendors and  
20 service providers and provide quarterly updates to state  
agencies. Funds provide for a 3-month project Planning and  
22 Research Associate position, a computer and software, purchase of  
an updated vendor list, printing and postage.'
