18	order to promulgate rules, screen approximately 1,600 vendors and service providers and provide quarterly updates to state		
20	agencies. Funds provide for a 3-month project Planning and Research Associate position, a computer and software, purchase of		
22	an updated vendor list, printing and postage.'
