Further amend the resolve in section 2 by striking out all of subsection 3 and inserting in its place the following:

Three postsecondary education employees; one from the 24 University of Maine System chosen by the Governor from a list of nominees supplied by the Chancellor of the University of Maine System; one from the Maine Technical College System chosen by the 26 President of the Senate from a list of nominees supplied by the President of the Maine Technical College System; one from the Maine Maritime Academy chosen by the Speaker of the House of Representatives from a list of nominees supplied by the President of the Maine Maritime Academy;'

Further amend the resolve in section 2 in subsection 9 in 34 the last line (page 1, line 44 in L.D.) by striking out the following: "and"

Further amend the resolve in section 2 by striking out all of subsection 10 and inserting in its place the following: 38

One Senator serving on the Joint Standing Committee on 44 11. Education appointed by the President of the Senate; and

Further amend the resolve by inserting before the statement of fact the following:

'FISCAL NOTE

This resolve establishes the Maine Committee for Global Education and allows the Legislative Council to accept and administer outside sources of funding to conduct the study. If no outside funding is available, the committee may not incur In particular, General Fund expenditures are expenditures. prohibited.'

STATEMENT OF FACT

This amendment changes the membership of the Maine Committee for Global Education and provides for a cochair to be elected by committee members. It adds encouraging development of new international exchange programs as a committee duty and permits the committee to submit legislation annually, if needed. 22

24 The amendment deletes the requirement that the Department of Education and the Department of Economic and Community Development provide staff support to the committee and permits 26 organizations whose members serve on the committee to provide 28 staff assistance instead. It also makes clear that the Legislative Council may administer outside funds to finance the 30 activities of the committee, including paying expenses of committee members and prohibits expenditures from the General 32 Fund.

The amendment also adds a fiscal note to the bill.
