STATEMENT OF FACT

This amendment clarifies obligations of the Town of Richmond and the County of Sagadahoc and specifies that the county commissioners of Sagadahoc and the municipal officers of Richmond determine the existing bonded indebtedness of Richmond in a just and equitable fashion.

This amendment also clarifies the application of the bill pertaining to the effective date of the obligations to Lincoln County and makes other necessary technical corrections.
