HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to S.P. 683,
L.D. 1811, Bill, "An Act to Annex the Town of Richmond to Lincoln
County"

Amend the amendment by inserting after the 6th indented
paragraph after the title (page 1, line 38 in amendment) the
following:

'Further amend the bill in section 2 in the first 2 lines
(page 1, lines 6 and 7 in L.D.) by striking out the following:
"If this Act is approved by town and county voters of the Town of
Richmond, the" and inserting in its place the following: 'The'

Further amend the bill in section 2 by striking out all of
the last sentence (page 1, lines 10 to 12 in L.D.) and inserting
in its place the following: 'The indebtedness of the Town of
Richmond to the County of Sagadahoc must be determined in a just
and equitable manner by the commissioners of Sagadahoc County and
the municipal officers of Richmond by March 15, 1992.'

Further amend the bill in section 3 in the last line (page
1, line 16 in L.D.) by striking out the following: "the effective
date of this Act" and inserting in its place the following:
'January 1, 1992'

Further amend the bill in section 5 in the 5th paragraph in
the 3rd line (page 1, line 50 in L.D.) by striking out the
following: "town" and inserting in its place the following:
'county'

Further amend the amendment by striking out all of the 7th
indented paragraph after the title (page 1, lines 39 to 41 in
amendment) and inserting in its place the following:

2 'Further amend the bill in section 5 in the 5th paragraph in
the 3rd line (page 1, line 50 in L.D.) by striking out the
4 following: "the general election in 1992" and inserting in its
place the following: 'elections to be held on November 5, 1991''

8 Further amend the amendment by inserting after the 7th
paragraph after the title the following:

10 'Further amend the bill in section 5 in the 3rd paragraph
from the end in the first line (page 2, line 10 in L.D.) by
12 striking out the following: "This Act takes effect upon
acceptance by" and inserting in its place the following:
14 'Approval of this Act in each county requires' and in the 2nd
line (page 2, line 11 in L.D.) by striking out the following: "
16 and further" and in the 4th line (page 2, line 13 in L.D.) by
inserting after the following: "Act" the following: 'in each
18 county' and in the 5th line (page 2, line 14 in L.D.) by striking
out the following: "the town" and inserting in its place the
20 following: 'that county' '

22 Further amend the amendment in the emergency clause in the
last line (page 2, line 3 in amendment) by inserting after the
24 following: "preamble," the following: 'section 5 of'

28 **STATEMENT OF FACT**

30 This amendment clarifies obligations of the Town of Richmond
and the County of Sagadahoc and specifies that the county
32 commissioners of Sagadahoc and the municipal officers of Richmond
determine the existing bonded indebtedness of Richmond in a just
and equitable fashion.

34 This amendment also clarifies the application of the bill
36 pertaining to the effective date of the obligations to Lincoln
County and makes other necessary technical corrections.
