Emergency preamble. Whereas, Acts and resolves of the 2 Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and 4 Whereas, the people of the State have ratified the issuance of bonds for improved public safety facilities; and б 8 Whereas, the proceeds from the sale of these bonds are to be allocated by the Legislature; and 10 Whereas, the present Department of Public Safety building at Thomaston should be replaced rather than repaired; and 12 Whereas, it is necessary to adjust available balances 14 between projects to ensure completion of all improvements; and 16 Whereas, completion of public safety improvements is of 8993 I.J.A.F 18 paramount importance; and 1981 - M. ## STATEMENT OF FACT

Following ratification of a bond issue that allowed for improvements in public safety facilities the Legislature allocated the proceeds from the sale of the bonds to certain 6 8 public safety projects. Some projects have been completed and others have been started or are in the planning stage. The 10 allocated balances for the projects need to be adjusted to allow for completion. In addition, further study has shown that the barracks at Thomaston should be replaced rather than repaired. 12 This resolve adjusts the balances between projects and amends the 14 language regarding the Thomaston site to allow for new construction rather than building repair.
