Be it enacted by the People of the State of Maine as follows:

Sec. 1. P&SL 1963, c. 154, §24 is enacted to read:

Sec. 24. Dissolution. The district may be dissolved by affirmative vote of a majority of the legal voters voting at a б municipal election on the question: "Shall the Berwick Sewer District, created as a quasi-municipal corporation by Private and 8. Special Act, be dissolved?" Prior to dissolution, the district shall adequately provide for the transfer of the district's 10 assets, liabilities and responsibilities.

Sec. 2. Town of Berwick; duties upon dissolution. Upon 14 dissolution of the Berwick Sewer District, as created by Private and Special Law 1963, chapter 154, the Town of Berwick shall 16 assume the assets, liabilities and responsibilities of the district. فالمحفقين عرارات
