The remaining unclaimed minimum deposits, any other unclaimed deposits and any income earned on deposits become the property of the distributor on the day payment is made to the Treasurer of State. <u>Deposit initiators under section 1863-A, subsection 1 shall retain all unclaimed deposits.</u> Funds received by the Treasurer of State under this subsection become the property of the State and must be deposited in the Maine Solid Waste Management Fund established in Title 38, section 2201.' '

26 The amendment leaves initiators of deposit of refillable containers subject to current reporting requirements and 28 clarifies that all other unclaimed minimum deposits escheat to the State with 50% retained by the deposit initiators. 30
